Our students are not meeting proficiency targets in math. Only 8.6% of our students scored proficient or advanced in Math Even though it is an increase, it is still a challenge.

Our White suppopulation remained stagnant at 4.5% proficient and advanced

Our English Learner suppopulation remained stagnant at 7.4% proficient and advanced

#### **Most Notable Observations/Patterns**

We noticed a theme of planning together as a grade level or team and looking at data to guide instruction. According to the focus group data, majority of the participants felt that the administration was supportive and the principal and assistant principal worked together and walk the building everyday to greet teachers and students. Staff survey data indicates 84% feel leadership team communicates a clear mission, and 92% feel leadership sets high expectations for students and staff. 82% of the parents who completed the survey feel the school sets high expectations for students.
