Facilities and Security

The Facilities and Security Committee presented a total of 4 resolutions for consideration. The motion was made by Mr. Cooper, and this was seconded by Mrs. McCree.

Res. 1 Awards bid to Uhrig Construction, the lowest responsible bidder for General Construction, at the 6th Grade Magnet School for Performing Arts (former Jewish Community Center) at a cost of \$1,176,000.00, upon contract approval from the Pennsylvania Department of Education and solicitor. This includes alternate GI-Pool Renovations at \$124,000.00, and alternate G-2, finishing new Classroom 142 located on the second floor above the handball courts at \$18,600. All alternates in this resolution are included in the base bid of \$1,176,000.00. Monies to be taken from the 2008 Bond Fund. **A-Res. 1**

Res. 2 Awards bid to Vision Mechanical, the lowest responsible bidder for Plumbing, at the 8th Grade Magnet School for Performing Arts (former Jewish Community Center) at a cost of \$278,000.00 upon contract approval from the Pennsylvania Department of Education and solicitor. Monies to be taken from the 2008 Bond. No Alternates.

Res. 3 Awards WARKO Group the lowest responsible bidder for HVAC at the 6th Grade Magnet School for Performing Arts (former Jewish Community Center) at a cost of \$910,000.00 upon contract approval from the Pennsylvania Department of Education and solicitor. This includes Alternate H-3 HVAC Boilers for \$82,000 and Alternate H-4 Pool Dehumidification Unit at \$122,000.00. Per architect and mechanical engineer recommendations, credit amount of \$25,000.00 for Alternate H-1 HVAC Instruments is not to be approved. This does not affect the base bid of \$910,000.00. See attachment. Monies to be taken from the 2008 Bond Fund.

Res. 4 Awards bid to Hirneisen Electric, the lowest responsible bidder for Electrical Construction, at the 6th Grade Magnet School for Performing Arts (former Jewish Community Center) at a cost of \$657,888.00 upon contract approval from the Pennsylvania Department of Education and solicitor. This includes Alternate E2-HVAC Boilers at \$510.00, Alternate E3-Pool Dehumidification Unit for \$7,200, and Alternate E4-Pool Ultra-Violet Water Treatment System at \$210.00. All alternates in this resolution are included in the base bid of \$657,888. Monies to be taken from 2008 Bond Fund.
